THIS CONTRACT constitutes the sole, complete and binding agreement between PATRICIA HAGER and Purchaser.

ADDITIONAL TERMS AND CONDITIONS: If above mentioned event is an outdoor function, tree shade, canopy, awning, or gazebo with roof must be provided to protect harp from direct sun. In addition, please have a rain alternative as the harp must not get wet.

Outside temperature must not be below 60 degrees or above 98 degrees. Please provide electrical plug if amplification is needed. For hotel ballrooms, microphone should be provided by the hotel. An additional parking fee of \$15.00 will be added to all events scheduled at hotels in downtown Austin or San Antonio.

WEDDINGS: PATRICIA HAGER usually does not attend wedding rehearsals. If Purchaser requests her presence at the rehearsal, this will require an additional fee. Music selection is by phone after listening to options at www.patriciahager.com.

In-person consultation may be scheduled at no additional charge.

Musicians have wedding schedules and must leave on time for the next bride. There will be an additional \$25.00 charge for weddings beginning more than 20 minutes late.
